#### MANAGEMENT'S REPORT

#### MACROECONOMIC SCENARIO

Over the past year, the spread of the pandemic and the actions taken by governments to curb it continued to have a significant impact on global growth prospects. During the summer of 2020, thanks to the reopening of activities previously subject to restrictions during the spring lockdown, a significant acceleration in growth was observed, in particular in the advanced economies. However, in the final part of the year and at the beginning of 2021 a new wave of coronavirus infections, especially in Europe, led to new restrictive measures, which, although less heavy than those imposed in the spring, brought the economy back into recession at the turn of the new year. In the US, despite a very high number of Covid-19 cases, the impact on the economy was less severe. The first months of 2021 were characterised by high growth rates in the US, as a result of the huge fiscal support approved by the Congress. In fact, after the support package approved in late December, the unexpected victory in early January of the Democratic Party in the ballots for the two seats in the Senate of Georgia allowed President Biden's Party to control both branches of Congress. The support package proposed by President Biden (close to two trillion dollars) thus became law in early March. In the first part of 2021 the US growth was also supported by the rapid vaccine rollout which kept the pandemic under control. At the beginning of 2021, in other parts of the world, the negative impact of the pandemic continued to burden economic activity. In spring, the vaccination campaign sped up in the Eurozone too, thereby allowing the reopening of economic activities, with a significant positive impact on GDP growth, which, indeed, accelerated so significantly to even exceed the pace of the United States in the second quarter. At the end of 2020 China was already back on its pre-Covid-19 growth trajectory and in the first part of 2021 it continued to grow at a fairly sustained pace, although consumption levels were not particularly robust. Chinese growth slowed down in a striking and unexpected way during the summer, also in response to strict restrictive measures introduced by the authorities to curb some limited Covid-19 outbreaks. During spring, an acceleration in growth in the US was associated with an unexpected increase in inflation, mainly due to transitory factors such as bottlenecks in supply chains and the impact of the reopening of some service sectors. In the rest of the world, the increase in inflation has generally been more modest, despite the upward pressures on raw material prices. The sharp and unexpected rise in inflation also prompted the FED at its June Federal Open Market Committee (FOMC) meeting to depart from its accommodative stance on monetary policy. The ECB, on the other hand, responded to the upward pressures on the market rates triggered at the beginning of the year by the changed fiscal policy scenario in the US, with the decision taken at its March meeting to increase the pace of securities purchases in the Pandemic Emergency Purchase Programme (PEPP), Finally, at the beginning of July, given the signs of a slowdown in the economy, the PBoC unexpectedly decided to reduce the required reserve ratio.

In the US, after a slowdown in the final months of 2020, mainly arising from the negative impact of the spread of the pandemic on private consumption, domestic final demand accelerated in the first months of the year at a pace last seen in the mid-80s, thanks to the two fiscal support packages approved by Congress. The first (worth approximately 900 billion dollars) was voted by Congress in December 2020, the second one, proposed by the newly installed Biden Administration and (worth approximately \$ 1,900 billion, well above market expectations) was launched at the beginning of March. Both packages included transfers immediately granted to households, which helped to support consumer spending. In the first weeks of 2021, consumption and, more generally, economic activity, further benefited from the rapid process of vaccine rollout. GDP growth exceeded 6% annualised, in both the first and second quarters, despite the large negative contribution of inventories (due to the imbalance between supply and demand in the short run). This imbalance was also reflected in the dynamics of inflation which from April started to accelerate well above expectations, reaching a peak of 5.4% for total inflation and 4.5% for core inflation (i.e. net of fuels and food) in June. Inflation has been driven upwards by problems in supply chains (e.g. in the automotive sector), bottlenecks in sectors subject to reopening and a large favourable "base effect". The increase in prices, although much higher than expected, remained contained in a rather limited number of goods and services and during summer there was also a deceleration in inflation. During the first months of the year, the FED maintained a very dovish stance, despite the improvement in the economic situation, mainly because it considered it premature to start the internal debate on the reduction of securities purchases (the so-called "tapering"). A more restrictive stance kicked in at the mid-June meeting, when FOMC projections indicated a possible rate hike before the end of

In the Euro Area, the significant recovery in the economic activity during the summer of 2020, due to the reopening following the lockdown, was followed by a return to recession in the final quarter of the year, when a new wave of Covid-19 spread required governments to continue to adopt severe restrictive measures on mobility (although less heavy than those adopted in the initial phase of the pandemic) until April 2021. In addition, the uncertainty on the start of the vaccination program caused by problems with vaccine supplies, negatively affected the growth prospects in the Eurozone. However, the economy proved to have progressively adapted to the pandemic and, in the first quarter, GDP contracted (-1.1% t/t annualised) to a much lower extent than expected. Since the first months of 2021 the manufacturing sector has in fact benefited from the recovery of the international trade, while the service sector has started to accelerate especially in the second quarter, thanks to a greater social mobility and the rump up of the vaccination campaign. At the end of June, the goal of administering at least one dose of vaccine to 50% of the population in the Eurozone was reached. GDP growth reached very high rates (over 9% annualised) in the second quarter and remained robust even in the first part of the summer. After being particularly low at the beginning of the pandemic, inflation has shown a significant rise since the beginning of 2021, due to the combination of a number of factors, mostly temporary. Total inflation rose from -0.3% in September 2020 to 0.9% in January 2021 to peak as high as 3.0% in August. Core inflation also accelerated in late summer, reaching 1.6% in August. After having increased the amount of the PEPP securities purchase programme in December, the ECB confirmed an accommodative monetary policy, reiterating the transitory nature of the rise in inflation and the need to maintain financial conditions as favourable as possible. Therefore, in March, the ECB decided to respond to the rise in market rates, resulting from the upward movement of the US curve, by significantly increasing the purchases of securities in the PEPP programme in the second quarter; a decision that was also confirmed in the June meeting, valid for the third quarter.

### MANAGEMENT'S REPORT (CONTINUED)

**In Asia**, the economic activity continued to be influenced by the government efforts to control the pandemic, complicated by the spread of variants and slow vaccination rollouts. The economic policy continued to support growth.

In China there was a significant acceleration in growth already in the final part of 2020 and the success in containing the pandemic allowed the resumption of growth to continue even into the beginning of 2021, thanks to a particularly robust foreign demand, while instead, consumption struggled to recover in a stable way. At the beginning of 2021, the economic policy entered a phase of gradual normalisation with overall credit decelerating, especially in the non-banking component. However, during summer, growth slowed down considerably as a result of more cautious fiscal, monetary and credit policies enacted in the first half of the year, as well as a result of new restrictions imposed to contain limited Covid-19 outbreaks. In early July, in response to the economic slowdown, the PBoC unexpectedly cut the required reserve ratio and the fiscal policy also became more expansionary.

The Japanese economy had to deal with multiple waves of infections, which forced the authorities to introduce a series of restrictive measures, while the first phase of the vaccine campaign went slowly. After the recovery recorded in the second half of 2020, GDP underwent a new contraction in the first quarter of the year, before rising again at modest rates in the following one. The BoJ didn't significantly change its monetary policy throughout the period.

#### **EQUITY MARKETS**

2020 left investors with a smile. Stocks, bonds, and commodities had another strong positive double-digit year. The US election paved the way for a series of fiscal stimulus to reignite growth and the approval of the first Covid-19 vaccine in November gave the market the possibility to dream of a new normal again.

The geopolitical concerns started to ease and the increase in the vaccination rate coupled with the reduction of infections and deaths had a massive impact on the economies. UK officially left Europe (Brexit) at the end of 2020 with a tentative deal that was enough to address most of the concerns and let the FTSE index move higher with the rest.

After nearly two years of a different life, consumers were ready to go out and spend again. The Reopening trade became the new mantra.

The momentum carried into January where cyclical and value stocks outperformed growth and technology for the first time in 10 years. The positive macroeconomic data fuelled the rally for stocks lead by the US and Europe. Earnings all over the world kept on surprising and companies continued to raise outlook and guidance. Market momentum seemed to pause around mid-year when the world got worried for the low pace of vaccinations and the slowdown in vaccine production. However, even that proved to be temporary.

The speed of the recovery and the massive increase in demand turned the attention of the investor to a problem left in the drawer for a long time: inflation

Central banks with the Federal Reserve leading the way hinted several times to a higher attention to the issue but still considering the increase in prices as transitory. Policy interventions fiscal and monetary are still in place supporting the economy.

However, the recent data especially in China have started to signal a potential peak in growth. For the next, few months it will be very important to dissect the future of the real economy and the expected growth, being the market at its highest level in a decade.

**United States:** The after-Trump era started with Biden as new President and with him a stable government as well was in place. From there, the US was able to start the recovery plan. US equities gained over the year, with November especially strong due to the vaccine news. The developments eclipsed Joe Biden's win in the US presidential election, as well as a \$900 billion stimulus package announced in late December. The Federal Reserve nonetheless reinforced its supportive message, stating it will continue with current levels of quantitative easing. Economically sensitive sectors made the strongest gains in the first part of the year, with more defensive sectors making modest progress. The approval of the Covid-19 vaccine and the subsequent vaccination campaign has driven the economy and the stock market rewarding cyclical and value stocks. The US market ended the year in positive territory with a double-digit performance.

**Eurozone:** European equities gained sharply during the year, again on the news of effective vaccines. Sectors that had previously suffered most severely from the pandemic, such as energy and financials, were the top gainers. However, rising Covid-19 infections saw many European countries tighten restrictions. EU leaders approved the landmark €1.8 trillion budget package, including the €750 billion recovery fund, after overcoming opposition from Hungary and Poland. The EU agreed a Brexit trade deal with the UK. Cyclical and value stocks outperformed strongly in the first part of the year with energy and financials leading the way.

**United Kingdom:** What benefited the UK market was not the fact that they left the EU but the massive vaccination campaign. From late November, the long run of growth stocks was reversed, and value rallied as news of the success in vaccine development broke. Indeed, during the year value stocks outperformed its growth peers. UK equity indices have a value bias, with overweight to sectors such as Financials and Energy, which rallied strongly at the same time

**Japan:** Death rates from Covid-19 have been much lower than those in other major developed economies. However, the acceleration in the number of new cases at the end of 2019 was serious enough for the government to make anti-pandemic measures mandatory for the first time. Despite this being likely to weigh on still-weak domestic demand. Tokyo stocks still managed to rise from December onward as the government announced a new stimulus package to support the economy.

China: The Chinese equity market benefited from strong portfolio inflows during the first quarter of the year being one of the best performers up to February 2021. The prevailing narrative reversed completely in the last two quarters when news emerged of a much heavier regulatory stance against internet stocks took its toll and caused significant underperformance of Chinese equities (especially for US listed ADRs). Government intervention had a significant impact on several sectors (fintech, ecommerce, education, pharmaceuticals, casinos' operators) and left many observers wondering if the government approach towards private enterprise has changed in a substantial way under the Xi Jinping administration. More recently, the likelihood of a possible default of Chinas biggest private developer, Evergrande, has significantly increased. Government intervention to bail out its creditors in order to prevent panic among homebuyers and savers is expected by most observers. Nonetheless, tail risks of spillover effects to the economy are not negligible considering the size of the Chinese real estate sector.

### **FIXED INCOME MARKETS**

In September 2020, the economic outlook was grim. We did not know how the Virus would progress, with no vaccine and the majority of the globe in lockdown. Developed economies embarked in aggressive monetary easing, negative real yield, and very loose fiscal policies. The combined effect turned out to be extremely good for risky assets. The good news came towards November 2020 when the efficacy of the vaccines turned out to be excellent and soon after the vaccination roll out started.

Inflation started to print higher in the US due to shortages, to supply disruptions and a tight job market. The most dramatic change in fixed income has been inflation and inflation expectations. The US CPI moved from about 1% a year ago to about 5%. However, the 10y treasury yield moved only from 0.70% to 1.30%, with a top in March 2021 at 1.75%. So, despite having a better outlook and clearly strong inflation, the 10y US real yield remained about the same slightly above 1%. The dominant narrative is "debt does not matter" as the FED will run the economy hot and it will take a long time before rates start to rise. The overall supply of government bonds has been well absorbed by the markets but thanks to the global QE which is depressing bond yields.

In Europe, the ECB increased its QE in Q2 2021 as the virus damage was spreading. The deficits will not be dropping as much as expected this year. The plan is for the Growth and Stability pack to be back in implementation in 2023. The syndication of issuance of debt through EU-Sure and EU-Next Gen has been a success and it may be as temporary as declared.

Looking forward, we expect the ECB to revert back that increase in Q4. The FED has prepared the market for a tapering of its QE before year end. Still, we are a long way from a rate hike as negative real yields are helping the very leveraged economies to service their debt. But the longer it stays the same the more the imbalances are rising and the fickler the financial stability becomes.

In emerging markets economies, we experienced procyclical monetary policies probably for the first time in history. The fact that the component of debt in external debt have materially reduced in the past 2 decades, thanks to more mature local currency funding markets, gave EM central banks the option to implement accommodative monetary policies characterized by a controlled FX depreciation. As inflation pressures have materialized more forcefully in the past months, monetary authorities have started pre-emptive normalization policies in order to preserve financial stability.

### FOREIGN EXCHANGE MARKETS

The past year has been a remarkably calm period for the foreign exchange market. The financial landscape is heavily controlled by central banks leading to reduced volatility in a wide range of currencies.

The Euro/USD exchange rate has maintained a very tight range over the past 12 months, starting and ending the period less than a big figure different. The lack of volatility throughout the year was very noticeable as the peak to trough range was under 6%. Broadly similar responses to the pandemic crisis on both sides of the Atlantic is the main catalyst for the misery move.

The difference in the exchange rates between the Scandinavian currencies and the Euro from one yearto the other was anemic. Also, the Swiss franc deviated very little from its opening to its closing level.

Sterling had a slightly more positive tone throughout the period. After an initial poor management of the pandemic by the UK government, a very prompt and efficient vaccine roll out programme helped the economy normalise at a faster pace. The pound closed the year over 3 1/2% stronger against the Euro

The Japanese Yen managed to create more volatility as the evolution of the virus varied between Asia and Europe to a larger degree. As positivity around the containment of the virus grew, global markets envisaged a rosier outcome. As a result, risk on trades prevailed and the Euro was able to make decent gains against the Yen. However, as the delta variant spread, and the Tokyo Olympics resulted in a spike in cases, the single currency relinquished some of its gains but still closed the year in positive territory.

The commodity linked economies in the developed market space saw their currencies perform well. A strong rebound in the oil price aided the performance of the Canadian dollar, whereas soft commodity gains lent support to the New Zealand dollar.

### **MANAGEMENT'S REPORT (CONTINUED)**

Over the course of the past 12 months, there was plenty of divergence within the emerging market currency performances. The South African rand led the way, gaining on the back of the strong commodity market. The Chinese Renminbi also performed well against the Euro as China both entered and emerged from the pandemic sooner than the west. At the other end of the scale, the Turkish lira was very weak over the past year, as Turkey grapples with pandemic factors and rapidly rising inflation.

#### TRENDS OF SUB-FUND'S

#### AILIS RISK PREMIA CARRY dormant as of March 31, 2021

During the period 01/09/2020 to 31/03/2021, most of the sub-fund's positive performance was generated in November, mainly on the back of Volatility Carry (both Equity and Commodity Volatility), Dividend and Credit Carry strategies.

At the time positive vaccine news triggered a significant market repositioning. In the month prior, the headlines focused on a second wave of Covid-19 infections and on the U.S. presidential election.

The sub-fund is running at a lower level of exposure due to risk measures, the scenario for carry strategies seems positive but volatility especially in credit and commodities is clearly increasing.

### AILIS RISK PREMIA EQUITY dormant as of March 31, 2021

During the period 01/09/2020 to 31/03/2021, majority of sub-fund's negative performance was generated in February mainly on the back of Equity Momentum and Equity Quality. The strategies' underlying short legs produced most of the losses, and long legs to a slightly lesser extent.

At the time, the market was optimistic from continued fiscal and monetary support, progress in vaccine rollout and improving corporate earnings outweighed concerns over rising inflation, future of central bank support in addition to the continuing pandemic related lockdowns and mobility restrictions.

## AILIS RISK PREMIA MOMENTUM dormant as of March 31, 2021

Most of the sub-fund's positive performance was generated from November onwards, after the U.S. election and positive coronavirus vaccine news.

The largest performance contributor was the Commodity Momentum strategy. Commodities longs benefited with investors betting on even stronger demand in the coming years as governments stimulate their economies and promote renewable energy and electric-vehicle infrastructure.

In addition, the sub-fund benefited from the CTA and Equity Momentum strategies.

#### AILIS RISK PREMIA QUALITY dormant as of March 31, 2021

Most of the sub-fund's negative performance was generated in November when positive vaccine news triggered a significant market repositioning. In the month prior, the headlines focused on a second wave of Covid-19 infections and on the U.S. presidential election.

In November, the bulk of underperformance was driven by the short legs, and by stocks selected in almost all sectors, in particular by long healthcare

#### AILIS RISK PREMIA VALUE dormant as of March 31, 2021

Most of the sub-fund's positive performance was generated in March on the back of Equity Value, Equity Mean Reversion, and Commodity Value strategies.

At the time, investors were betting on even stronger commodity demand in the coming years as governments stimulate their economies and promote renewable energy and electric-vehicle infrastructure.

#### **AILIS M&G COLLECTION**

Positioning - During the fiscal year, the portfolio was positioned to provide broad diversification across asset classes. Asset allocation was also scaled dynamically in response to changing market conditions, as well as asset valuations and correlations, in line with the investment strategy. Major portfolio themes included long exposure to global equities, particularly cyclical sectors; long positions in long-dated USTs for portfolio protection; and emerging market debt and currencies for idiosyncratic diversification and high carry. In March 2021, a short position in five-year USTs was added to diversify interest rate risk. Equity exposure averaged 31.1% of portfolio NAV during the period. There was a significant allocation to the financial sector, averaging 8.3% of NAV. Duration was relatively high for the first half of the review period. At the end of February 2021, it was 5.5 years. This was reduced following the introduction of the short five-year UST position and gradual scaling back of long-dated USTs. At the end of August 2021, duration was 3.4 years.

Performance - The portfolio delivered a strong positive return overall, with allocations to the financial, healthcare and mining sectors making notable contributions. Equity allocations to non-US regions, notably.

Europe and Asia including Japan, also proved beneficial. Emerging market bonds and global credit delivered positive returns overall. Long and short UST positions dragged on performance, having been added and/or scaled at different times to diversify risk. Underweight exposure to US equities detracted from relative performance towards the end of the review period, as growth stocks rebounded.

The portfolio retained a meaningful exposure to equities, which helped to capture the asset class's outperformance. Performance also benefited from tactical scaling, with October's volatility, in particular, presenting an opportunity to increase equity weighting. Subsequent rallies in November allowed the team to realize some of these gains by de-risking. Bonds sold off at the start of 2021, which negatively impacted the portfolio's allocations to long-dated USTs and emerging market bonds. Since the short UST position was added, the market's inflation fears have cooled – at least for now – which meant this holding also detracted.

Market Outlook/Expectations - The portfolio's positioning remains balanced across a variety of asset classes with a view to providing scope to respond should market volatility return. This should allow the portfolio to benefit from the ongoing economic recovery while also offering potential protection against any moderate future interest rate rises or setbacks. The market's main concerns appear to be a US 'taper tantrum' or a loss of control over inflation by the US Federal Reserve. The intensity to which these issues are being debated suggests these fears may already be partially priced in. With regards to the effects of any potential US tapering on emerging markets (EM), it is important to remember that EM bonds and currencies were overvalued in 2013. The US Federal Reserve is also keen to avoid a repeat of 2013's events, which would suggest a reduced risk to EMs compared to eight years ago.

### AILIS INVESCO INCOME

Positioning - At the start of the review period the sub-fund's equity exposure was around 35%, while at the end was 32%. Within the bond portfolio, the largest credit sector exposure remains banks at 11%, with the highest allocation to AT1 bank capital. A relatively high allocation to liquidity is maintained through cash and US Treasuries (both nominal and inflation linked).

The sub-fund's largest sectors were:

a) Equity +1,132bps

Top 3 stocks - (1) Samsung Electronics +85.2bps (2) JPMorgan Chase +83.7bps (3) TSMC +82.9bps

b) Credit +455bps

Top 3 - (1) High yield +169bps (2) Subordinated financials +163bps (3) Investment grade +50bps

c) Duration +113bps

Performance - All areas of the portfolio delivered positive returns. The sub-fund returned a positive absolute performance over the one-year review period. Returns were driven by equity gains which benefited from a sharp global economic recovery that was aided by huge government stimulus packages aimed at supporting businesses and households during the pandemic. The bond allocation also delivered positive returns with high yield and subordinated financials contributing the most. Supported by lower bond yields, duration was another contributor

Market Outlook - In recent months several factors have combined to potentially power a strong cyclical upswing in the global economy. This environment should continue to be constructive of equities in our opinion. However, outlook for bond markets is likely to be more challenging. Bond yields are very low and credit spreads are close to historic lows. Against this backdrop the investment team are maintaining a balanced approach with a relatively high allocation held in cash and short-dated bonds.

#### MANAGEMENT'S REPORT (CONTINUED)

#### AILIS MAN MULTI-ASSET

Positioning - The sub-fund actively manages exposure to the asset classes traded with the aim of maintaining a relatively stable return volatility in all markets. During the reporting period, the correlation overlay, which detects potential rising correlations between equities and bonds, fired towards the end of August 2020, lowering exposure with the aim of protecting capital. Exposure then ticked up towards year end as consistent lower market volatility across the asset classes drove the need for higher exposure. Coming into Q1 2021, the sub-fund saw a reduction in exposure primarily driven by the correlation overlay which extended its degear signal to its full capacity due to rising intra-day correlations between equities and bonds. In addition, the momentum overlay in bonds activated a cut the bond allocation further, helping the sub-fund avoid larger losses in bonds as bond yields rose. The sub-fund exposure to all asset classes increased significantly towards the end of the period as all risk overlays unwound and portfolio exposure moved towards full risk.

Performance – The sub-fund returned a positive absolute performance. All asset classes traded by the sub-fund contributed positively to performance over the period. Long stocks were the largest driver, the the S&P 500 and NASDAQ indices the top performers. Long bonds also profited, with US Treasuries and German bd positions adding. The commodity allocation did well, also generating profits.

In line with the investment philosophy of the sub-fund, in that it is easier to forecast risk than return, the portfolio managed allocations to the asset classes to achieve a stable level of portfolio volatility. During the period, prices rose across the asset classes traded, leading to positive performance Risk overlay activity heled avoid large losses in bonds in Q1 2021 although this did come with a slight performance drag as the portfolio missed a little of the equity rally.

Market Outlook - As a fully systematic sub-fund that focusses on forecasting risk, rather than return, the investment manager does not have a house view on market expectations going forward The sub-fund has historically, and will continue to, manage risk exposures actively to navigate the market environment. The investment manager will focus on maintaining an investment edge through research and by improving the sub-fund through time.

#### AILIS JPM FLEXIBLE ALLOCATION

Positioning - At the start of the period, the portfolio was underweight stocks vs. bonds, however the sub-fund incrementally increased our exposure to risk assets over the period. From January 2021, it was overweight equities and has been reducing its high cash allocation. The sub-fund increased our equity position as the portfolios ex-ante risk has remained below the hard ex-ante risk limit, and since April 2021, we are also below the soft ex-post risk limit.

Within equities, the sub-fund maintained our preference for cyclically geared regions such as Europe and Japan, given we expected yields to backup ahead of increased inflation expectations and above trend growth. We reduced our Emerging Markets equity position over the period, given the high exposure to Chinese internet names within the index, which we believed would underperform amidst the rotation towards more value-oriented sectors. We specifically opened a position in the JPM US Value Fund and JPM Europe Small Cap Fund, as a way of gaining exposure to the more cyclical and value-oriented sectors of the market. More recently, we have been increasing our position within US Large Cap, as we believe we are moving into the middle of the economic cycle and expect a renewed focus on the quality of earnings.

Within fixed income, the sub-fund remained underweight duration over the period, as we believed that yields would continue to back up, ahead of rhetoric around increased inflationary pressures in the US and markets continuing to price in higher global growth. Within government bonds, we preferred core European government bonds, as we saw a clear growth differential to the US, and we have now been concentrating our underweight in UK gilts as inflationary pressures have become more pronounced in the region. We continued to diversify our exposure into credit, across investment grade and high yield, however with riskless rates so low and spreads already tight, the capacity for further gains is more moderate and we have been reducing our exposure at the margin. Specifically, we diversified our high yield exposure into European High Yield, given support from the ECB, improving fundamentals in the asset class and positive news on the vaccine meant we saw scope for further spread compression.

Performance - The sub-fund returned a positive absolute performance due to underlying manager alpha, whilst asset allocation decisions slightly detracted from returns.

From a manager alpha perspective, the manager which generated the highest weighted alpha over the period was our JPM US Equity All Cap fund and investment grade credit manager. The only notable detractors over the period was our government bond manager and China A Share Opportunities Fund which slightly underperformed the respective benchmarks.

Our underweight equity vs. bond position detracted from performance over a 12-month period. We maintained our underweight equity position until January 2021, given we were breaching the hard ex-post volatility limit. Specifically, we concentrated our underweight in US equities, given the region exhibited higher volatility amid the Covid-19 pandemic and US election. As volatility has fallen, we have slowly increased our exposure and we are no longer breaching the soft or hard risk metrics. We, however, continue to proactively monitor the risk metrics of the portfolio on a regular basis and position the portfolio according to your Risk Policy.

Market Outlook - We believe the US economy has transitioned through the beginning of the economic cycle, whilst Europe is quickly moving through the early phase given the vaccine rollout.

Earnings revision ratios for major equity markets should continue to stay at elevated levels amidst the supportive macroeconomic environment which should continue to support risk assets.

Inflation should begin to subside, as secular forces such as technology, coupled with labor market slack reduce current pressure from base effects and supply chain disruption.

#### AILIS BLACKROCK MULTI-ASSET INCOME

Positioning - Over the course of the year, the sub-fund remained well diversified across asset class and region. Given a relatively constructive outlook, we maintained the sub-fund's pro-risk tilt.

The U.S. remained our preferred region due to encouraging virus and growth trends compared to the rest of the world. Elsewhere, we maintained our allocation to high yield bonds which we continue to view as attractive in a low-yielding world.

Lastly, we maintained the sub-fund's historic low duration (2.0 years) as we anticipate interest rates to move higher from here, despite reversing course in earlier this year.

Performance - Virtually all areas of the sub-fund contributed to total return during the period given a favorable backdrop for risk assets.

Key contributors to portfolio income in the reporting period (September 1, 2020 to August 31, 2021) were developed market equities, high yield bonds, and preferred stock. Developed market equities, high yield bonds, and a diversified multi-asset exposure were the largest contributors to total return this reporting period, offset by currency and duration management positions.

Market Outlook - The main event recently was the Federal Reserve's Jackson Hole symposium where investors searched for any clues on monetary tightening. While Chair Powell did not go as far as giving a specific timeline on tapering, he strongly signaled it could occur before year-end. Powell also continued to emphasize tapering does not signal rate hikes with the latter having a much higher bar for initiating. This, in addition to his conviction that the rise in inflation is largely transitory, implies that the hurdle for rate hikes in 2022 is high. Markets generally viewed this as dovish with risk assets rallying on the back of the meeting. Ultimately, we believe the U.S. economy is on strong enough footing for the Federal Reserve to move away from crisis-era policies and believe markets can digest such shifts.

That said, Covid-19 remains a key source of uncertainty and is starting to show an impact on economic activity. The most recent U.S. jobs report fell well below expectations and can be, at least partially, attributed to the virus. Other signs of softening economic momentum included a drop-in consumer confidence. Encouragingly, cases are starting to show signs of peaking in many areas.

Looking ahead, we still believe the pieces are in place to support a further rally in risk assets, namely massive liquidity, ongoing vaccination rollouts, and healthy corporates and consumers. Barring any significant negative Covid-19 developments tied to Delta or other new variants, our base case calls for higher U.S. interest rates, credit spreads to remain tight, and equities to grind higher. However, evolving fiscal and monetary policies, virus risks, and moderating growth all seem likely to create more volatility heading into the final months of the year.

### AILIS PIMCO TARGET 2024

2021 started with much fanfare for investors, following vaccine approvals and strong performance for risk assets throughout year-end 2020 and later in 2021. The beginning of 2021 was driven by continuous fiscal and monetary stimulus, together with vaccine rollout. Given these developments, markets moved to price in higher growth and more investors became concerned on inflation, with commodities reaching peaks and bonds selling off as real yields shifted higher. On the equity front, there was a shift from growth stocks to value stocks given the cyclical recovery. Summertime was focused on the new Chinese regulation paradigm, which imposed restrictions on the education and tech sectors and brought to a collapse in related stock prices. Recently, on the monetary front we saw markets anticipating hawkishness from the Fed on the back of another strong inflation print and strong labor market data.

In line with its Buy & Hold nature, the sub-fund has not seen striking changes to positioning since its inception in 2019. Currently the sub-fund allocates as follows: ~69% in IG credit, ~48% in HY credit, ~28% in External EM sovereign and quasi-sovereign debt, ~5% in Government or Government related debt. The sub-fund maintains a bias towards liquid exposure and thus gains part of its exposure to IG and HY debt via CDX instruments (~9% and ~24% respectively). In the IG space, given the expected cyclical recovery linked to re-opening of economies, the sub-fund keeps selective exposure to more cyclical issuers and industries, emphasizing balance sheet resilience and ample liquidity to limit potential downside, whereas in the HY space the emphasis is on senior secured bonds in industries with stable cash flows and growth fundamentals. In the EM space the sub-fund focuses on exposures in countries and corporates which demonstrate a consistent ability to repay their obligations and strong fundamentals.

Over the period, the sub-fund returned a positive absolute performance. Positioning and security selection both within IG credit, particularly in the Financials and Industrial (REITS, Transportation, Raw Materials) space, and in the HY credit, particularly in the Financials and Industrial (Automotive, Raw Materials, Food) space contributed to performance. Positioning in the hard currency EM was a net contributor among most of the countries. Duration exposure, especially in Europe, contributed to performance.

#### AILIS GLOBAL EQUITY MARKET NEUTRAL

During the twelve months ending August 31, 2021 the strategy averaged gross long exposure of 83% and gross short exposure of 68%, resulting in 15% net exposure across the portfolio. A reasonable benchmark for the sub-fund's performance is an adjusted Euro Stoxx 50 Index, which takes the sub-fund's average net exposure and multiplies it by the index return, resulting in a positive 4.68% performance, worse than the sub-fund positive 7.15% return

The sub-fund posted a 12-month volatility of 6.6%, less than half that of a 100% euro equity index (SX5E).

Since the realized beta remained inside a neutral range of -0.1 and 0.1, thanks to a lower volatility long equity basket and an average 82% hedging ratio with the Euro STOXX 50 Future, alpha generated by the strategy derived mainly from stock selection.

Major positive contributors were the sub-fund longs on Anglo American, El.En. and Texas Pacific Land while major negative contributors were long in Tgs Asa, implied short on Asml Holding and long on Relx.

The strategy continue to hold a well-diversified net exposure in a portfolio of low-leveraged companies, with good growth prospects, having an aggregate ROIC that is way above their WACC, in businesses that have historically produced higher average margins, for which the sub-fund is paying a lower multiple of sales, priced on average at a yield higher than the market free cash flow yield.

#### AILIS PICTET BALANCED MULTITREND

Positioning - The portfolio had a very positive performance for the year even though it underperformed a 50/50 equity / bond allocation.

The underweight in equity, kept to 43% till mid-March 2021 had a negative contribution due to a steady equity market growth for the period. For the last 6 months the equity investments were brought back to the 50% neutral stance, but that was not enough to close the underperformance

The conservative portion of the portfolio has been invested in government bonds for around 40% for the whole period and the rest in cash (up to 20%), in order to keep the duration risk under control. The cash part has been reduced once the equity portion was brought back to neutral

Performance - The sub-fund returned a positive absolute performance for the fiscal year.

The largest equity sector has been Information Technology with an average weight of 38% (rebased to 100%), followed by Health Care with 20% and Industrials with 15%.

The largest contribution came from Information Technology. Among the best performer it is worth mentioning Applied Materials (1,7% in the portfolio), an American producer of semiconductors that had a 120% performance in the period, as well as the consumer electronics company Zebra Technologies (1,9% of the portfolio) that gained 103%.

The largest relative detractor sector was Real Estate that had a 0% performance in the period, due to a very negative Q1 2021. In particular, negative contribution arrived from Vonovia, the German Real Estate company specialized in the residential sector.

The bond portfolio was invested in German and French government bonds till November 2020, in order to keep the risk under control, and then it was decided to include also Italy, Belgium and Spain.

Bond contribution was almost flat for the period (around 0,5%).

Market Outlook - The global economy is powering ahead despite the resurgence of Covid-19 infections while inflationary pressures continue to build, particularly in the US while Beijing's regulatory crackdown on industries such as tech, education and property drove down the local and emerging equity markets

Our business cycle analysis shows that economic activity is picking up strongly across the euro zone, following a sharp deceleration over the last two quarters. Retail sales have meanwhile recovered above the pre-pandemic trend in the region.

Balancing the economic resilience with the rising uncertainty, we prefer to retain an overall neutral allocation across equities, bonds and cash.

#### **AILIS MUZINICH TARGET 2025**

Global markets continued their strong rebound off of Q1 2020 Covid-19 lows, driven unevenly over the year by investor optimism over a post-Covid-19 reopening for the real economy. Additionally, of great importance, central banks around the world continued to fuel recovery through low or negative interest rates and asset purchases. The Fund's fiscal year has drawn to a close amidst stronger employment data, as well as inflation for commodities, goods, and services broadly. The Delta variant of Covid-19 continues to create some hesitation for Central Banks who appear to be watching numbers closely, but not quite yet acting to reign in market liquidity.

Positioning - Although this is a fixed maturity portfolio which can benefit from holding positions to maturity, the year included quite careful curating of positions held for the new Covid-19 and post-Covid-19 world order. Not all news was positive as the Chinese property company, Evergrande, was completely jettisoned at a controlled loss—a move which seems prescient now given recent news of a possible restructuring. In other cases, the portfolio benefitted from a focus on key reopening sectors, partially through purchases, but mostly through continued price recovery of high conviction names.

Results and Outlook - In this more optimistic environment for risk assets, the sub-fund delivered attractive performance led by outsized gains in a single Canadian position (Bombardier), and by broad gains across more emergent markets in Asia and the Middle East, Eastern Europe, and Latin America. The European periphery also performed strongly, and no region was negative. From a currency perspective, GBP starred as Brexit was completed at the end of 2020. Aerospace and defense outperformed on the already-mentioned Bombardier, but key gainers included insurance and reopening sectors such as gaming, super retail, metals and mining and steel which all delivered returns above 10% gross. Even the portfolio's "laggard"—containers— delivered a nearly 2% return. High yield generally outperformed investment grade. Credit appears broadly to be in good fundamental shape with few global defaults looming outside of China, perhaps, where the government can influence or determine company fortunes as part of its centralized campaigns. Valuations are, however, high, and vigilant credit monitoring remains a key defense against headline risk.

### AILIS FIDELITY FLEXIBLE LOW VOLATILITY

Market Review - Global equities performed positively over the review period. Equities rallied as large-scale fiscal and monetary policy measures unveiled globally to mitigate the economic impact of the pandemic boosted investor sentiment. A rebound in global economic activity and positive news around Covid-19 vaccines and treatments also supported equities. Notably, encouraging vaccine trial results towards end of 2020 and the subsequent roll-out of vaccination programs to combat the virus globally fueled optimism towards the ongoing economic recovery. However, rising infections and the re-imposition of targeted mobility restrictions in many regions; concerns over new, more infectious Covid-19 strains; and rise in inflation expectations kept markets volatile. Against this global backdrop, all key regional equity markets ended higher. From a sector perspective, financials and energy companies were among the leading performers. Fixed income markets generated mixed returns over the period, with corporate bonds outperforming government bonds. Within corporates, high yield bonds outperformed investment grade bonds. The massive monetary and fiscal stimulus on a global scale to cushion the economic impact of the Covid-19 pandemic helped reverse the spread widening. Credit spreads tightened amid an improvement in the growth outlook, better than expected economic data, rising Covid-19 vaccinations and strong corporate earnings.

Positioning - The top-level allocation to equity was increased while the fixed income exposure was reduced over the review period. Within the equity segment the underlying manager increased the allocation to communication services sector. In particular, the positions in Charter Communications and Cellnex were established. Meanwhile the exposure to the utilities sector was trimmed due to the broader risk-on sentiment as a result of fiscal and monetary support by global policymakers. At an underlying stock level, holdings in Xcel Energy and Eversource Energy were sold. Within the fixed income segment, the credit beta positioning was increased over the period on account of attractive valuations. Portfolio's duration was also increased amid heightened volatility in the rates market.

Performance - The sub-fund generated strong positive returns over the period supported largely by the equity segment. Holdings in the health care and information technology (IT) sectors added significant value. The resurgence of Covid-19 in several countries led to a spike in demand for health care facilities, while increased online activity and the shift towards working from home boosted demand for IT products and services. The financials, communication services and consumer staples sectors also contributed to returns. At the stock level, Google's parent company Alphabet and electronics company Keysight Technologies were the largest contributors to returns. The fixed income segment also generated a positive return over the period. Favourable credit strategy and high-income component supported performance, while the term structure positioning weighed on returns. At a sector level, the allocation to technology and communication contributed the most to performance. From a rating perspective, BBB rated credits were the highest contributors to returns.

#### AILIS FRANKLIN TEMPLETON EMERGING BALANCED

Benchmark US Treasury yields rose across the period, following sharp declines in early 2020 as the Covid-19 pandemic affected markets. They climbed sharply in the first quarter of 2021 on inflation concerns linked to stimulus measures, before falling back in the second quarter. In contrast, German 10y Bund yields were broadly flat, falling during the second half of 2020 as lockdowns affected the eurozone economy, before recovering as the economic outlook improved. Corporate credit and EM debt registered robust gains across the year, as spreads narrowed during a prolonged 'risk-on' period for markets, while oil prices benefitted from improved demand and supply restrictions following a steep fall in early 2020.

Global equities registered significant gains across the 12-month period to the end of August 2021, benefitting from unprecedented monetary and fiscal stimulus implemented by major central banks and governments. Developed markets led the way, although emerging markets (EMs) also rose by more than 20%, in euro terms.

The portfolio increased allocation to EM assets during the period, in line with stated objectives. The weighting increased from just over 12% at the start of the 12-month period to just under 21% by the end of August 2021. The increase was split across both equities and fixed income, including EM corporate debt and sovereign bonds. Allocation to the sub-fund's European buy-and-hold fixed income and broad global fixed income sleeves was reduced to accommodate allocation to EMs.

The sub-fund posted a positive absolute return over the fiscal year. EM equities were a significant contributor to absolute returns, as monetary and fiscal stimulus fuelled "risk-on" sentiment. Information technology and financial stocks were the main contributors. EM debt also helped results on narrowing spreads, particularly sovereign and high-yield issues. Elsewhere, both the global fixed income and European buy-and-hold sleeves contributed. Yields on core European developed market government bonds were broadly flat across the period, although certain issues benefitted from falling yields, notably Italian sovereign debt. Corporate bonds and EM debt added value on narrowing spreads.

#### AILIS MAN MULTI CREDIT

Positioning and Performance - Ailis Man Multi Credit returned 0.51% absolute performance in the 12 months ending on August 31, 2021.

Strategic positioning in credit outperformed indices, adding 4.53%, with investment grade credit contributing 3.20% and high yield contributing 1.33%.

The sub-fund held an average exposure of 53.9% to investment grade credit and 16.5% to high yield credit in the 12 months ending on August 31, 2021.

Over the same period, the global investment grade index returned 1.90%, whilst high yield returned 7.90%.

Over the period, the largest sector contributors to performance were Financials, Energy, Consumer Discretionary.

Standout individual credits include Occidental Petroleum, the AA group and Vivion, contributing 0.37%, 0.30% & 0.26% respectively.

Tactical positioning detracted -4.02% over the period, with core government bonds detracting -3.46% and CDS Index hedging detracting -1.19%, whilst non-core government bonds added 0.41% and currency positioning added 0.24%.

The sub-fund has in general held a cautious view on government bonds over the 12-month period, typically holding short duration positioning in core government bond markets, which also acted to hedge interest rate risk in the long credit portfolio.

Short positioning US bond futures was the largest detractor, although offset somewhat by gains in dollar denominated credit, in which the sub-fund has been overweight.

Long protection in CDS indices held in the last quarter of 2020 also detracted as credit markets rebounded. It was felt a cautious view was warranted at the time, and also allowed additional flexibility within the long credit portfolio to invest in more cyclicals sectors, which ultimately outperformed.

Within non-core government bonds, Italy was the largest driver of performance, contributing 0.43%.

FX positioning has contributed year to date, with a long sterling versus US dollar in Q1 and short Australian dollar versus US dollar in Q3 driving performance. A long Mexican peso versus US dollar position held in March was a moderate detractor.

Market outlook - Despite spreads being relatively tight, credit markets are likely to remain contained in the near term. Investment grade bonds remain well supported by central bank buying in Europe in particular, but also by the strengthening global economy that should support the credit upgrade cycle.

Unfortunately, valuations are not what they were a year ago, and in our view the best value is found in more idiosyncratic type credit opportunities that are less interest rate sensitive.

The team maintains a disciplined approach to valuation, cutting credits that rally past fair value targets from the portfolio.

With US Treasury yields having declined up to 0.65% lower from highs established near 1.80% in the 10-year earlier in the year, there is concern at the market's current complacency on inflation and tapering of QE in particular.

Supportive technical market dynamics do however have the ability to temper the risk or at least the magnitude of rising yields in the short term.

While yields may move lower near term, should inflation risks be pared further, there is less safety provided for investors in the highest quality government debt. The sub-fund is therefore likely to continue to be cautious on portfolio duration risk going forward, should yields remain at or near current levels.

#### MANAGEMENT'S REPORT (CONTINUED)

#### AILIS VONTOBEL GLOBAL ALLOCATION

Performance and Positioning - During the reporting period from September 1, 2020 to August 31, 2021, the performance of the sub-fund has been +2.65%. The sub-fund is invested for 27.27% equity, for 70.55% in bonds, while the cash represents 2.18%.

The equity component is tilted towards quality and growth factors and it is expected to be gradually increased, according to a proprietary model of asset allocation. The main sectors are Information Technology, Consumer Discretionary and Health Care. On the bond side, 32.09% is invested in Government Bonds, whereas 38.45% is invested in Investment Grade Corporate Bonds. The bond component is well diversified across regions and it presents a duration of roughly 6.00 years.

During the reporting period from September 1st, 2020 to August 31st, 2021, both the equity and the fixed income components contributed positively to the absolute performance. The main contributor is represented by the equity portfolio, in particular, by the exposure to US tech stocks. During the same period, the fixed income component did provide a positive contribution as well, mainly coming from corporate bonds. Regarding government bonds, although they performed very well in 2020, towards the end of the year and at the beginning of 2021, they experienced a bit of volatility due to rising rates, both in the US and in Europe. However, their contribution is still positive as of August 31, 2021.

Outlook - The main themes remain inflation, monetary policies and the pandemic. Central banks and governments are supporting the economy, but no additional packages are expected. Equities, most of them in record-breaking mode after stellar corporate earnings, may find it increasingly hard to continue their upward path especially during the next reporting season. Finally, economic activity is now decelerating after a previous strong rebound. China, for one, has disclosed unusually low growth rates.

#### AILIS JPM STEP IN ALLOCATION - first NAV November 2, 2020

Positioning - Since inception of the portfolio in November, we have been overweight equities vs bonds relative to the SAA. We maintained our view over the period that the increase in vaccinations would allow countries to gradually re-open and reduce lockdown restrictions. Global central banks remained accommodative, which we believed would ensure enough liquidity within markets and allow risk assets to rally.

Within equities, we maintained our preference for cyclically geared regions such as Europe and Japan, given we expected yields to backup ahead of increased inflation expectations and above trend growth. We reduced our Emerging Markets equity position over the period, given the high exposure to Chinese internet names within the index, which we believed would underperform amidst the rotation towards more value oriented sectors. We specifically opened a position in the JPM US Value Fund, as a way of gaining exposure to the more cyclical and value-oriented sectors of the market. More recently, we have been increasing our position within US Large Cap, as we believe we are moving into the middle of the economic cycle and expect a renewed focus on the quality of earnings.

Within fixed income, we remained underweight duration over the period, as we believed that yields would continue to back up, ahead of rhetoric around increased inflationary pressures in the US and markets continuing to price in higher global growth. Within government bonds, we preferred core European government bonds, as we saw a clear growth differential to the US, and we have now been concentrating our underweight in UK gilts as inflationary pressures have become more pronounced in the region. We continued to diversify our exposure into credit, across investment grade and high yield, however with riskless rates so low and spreads already tight, the capacity for further gains is more moderate and we have been reducing our exposure at the margin.

Performance – As at the end of August 2021, the sub-fund recorded a positive absolute performance since inception due to both underlying manager alpha and our asset allocation decisions.

From a manager alpha perspective, the manager which generated the highest weighted alpha over the period was our investment grade credit manager. The only notable detractors over the period was our government bond manager and Emerging Markets Research Enhanced Index fund which slightly underperformed the benchmark.

Asset allocation decisions positively contributed to performance over the period. Our long European and US Small Cap position was the driver of positive returns, whilst our short US 10 treasury future slightly detracted from returns, as yields gyrated over the period amidst expectations of above trend global growth being outweighed by concerns around the Covid-19 pandemic.

On an absolute basis, both our equity and fixed income allocation positively contributed to performance.

Market outlook - We believe the US economy has transitioned through the beginning of the economic cycle, whilst Europe is quickly moving through the early phase given the vaccine rollout.

Earnings revision ratios for major equity markets should continue to stay at elevated levels amidst the supportive macroeconomic environment which should continue to support risk assets.

Inflation should begin to subside, as secular forces such as technology, coupled with labour market slack reduce current pressure from base effects and supply chain disruption.

#### **MANAGEMENT'S REPORT (CONTINUED)**

#### AILIS SCHRODER GLOBAL THEMATIC - first NAV December 19, 2020

Positioning – The sub-fund had an allocation of 67.8% to equity and 32.2% to global credit at the end of August 2021. The equity exposure within the sub-fund has increased through the review period reflecting the relative performance of equities over bonds. The sub fund's equity exposure has remained relatively stable at a sector level. Information technology has been the largest position throughout reflecting the importance of technology to the themes of innovation, disruption and transformation that are played within the strategy. Exposure has been added to consumer and financials reflecting attractive investment opportunities identified in these areas. The global credit portion's largest underweights remain to banking, consumer noncyclicals and insurance due to valuations, while being overweight communications, which we like due to the growth of 5G theme.

Performance - The sub-fund delivered strong absolute returns and in doing so beat the performance of equity and credit benchmark indices. Stock selection was the primary driver of relative returns. For the equity portion of the portfolio, a strong contribution came from information technology, which comfortably outperformed the broader market, and industrials which benefitted from the recovery in economic activity post Covid-19. The sub-fund's underweight exposure to energy was the only notable detractor. The global credit portfolio posted strong positive returns and outperformed the benchmark as security selection, asset allocation and duration positioning all contributed. Consumer cyclicals, banking, energy and capital goods sectors contributed the most while an allocation to cash was the primary detractor.

In equities, some of the sub-fund's largest positions saw exceptional results and strong growth. Holdings in Google's parent company Alphabet benefitted both from strong search activity driving increased advertising revenues and momentum in the monetization of YouTube. In consumer, digital e-commerce and payment platforms SEA Ltd and MercadoLibre benefitted from structural and disruptive growth in Asia and LatAm where both are dominant players. In healthcare, Edwards Lifesciences, the medical technology company specializing in artificial heart valves and hemodynamic monitoring saw a continuing acceleration in demand for product supported by demographic trends. Outperformance in Credit was driven primarily by positive security selection within consumer cyclicals, followed by capital goods, banking, energy, technology and transportation. Corporate sector allocation was additive driven by an underweight to banking.

Market Outlook/ Expectations - The recovery in the global economy has been impressive both in terms of its speed and quantum. Progress in the roll-out of Covid-19 vaccines has been instrumental in this, buoying confidence and providing the platform for recovery in both industrial activity and personal consumption. This has supported strong equity and credit returns.

Despite indicators suggesting increased confidence in the economic environment, we think the near-term outlook remains finely balanced with the prospect of softening economic activity, supply chain disruptions and rising inflationary pressures. This represents increased risk.

That said, for the time being, equities should continue to benefit from a benign economic and earnings backdrop. Markets have however become trickier with a fair amount of optimism in the price and uncertainty increasing.

Global investment grade credit valuations are at historically tight levels and reflect the positive fundamental, macro and technical picture. This requires a more cautious approach due to valuations and low dispersion across sub-sectors which limits relative value opportunities.

The portfolio has therefore become incrementally more defensive with increasing emphasis on more defensive characteristics such as company quality, cashflows and financial resilience.

#### AILIS JANUS HENDERSON GLOBAL ACTIVE OPPORTUNITIES - first NAV December 22, 2020

Throughout the reporting period, the sub-fund returned a positive absolute performance.

Performance attribution analysis on the overall sub-fund level shows a very modest asset allocation effect between sleeves, compared to stock selection, the latter capturing style, sector, credit rating and security effects.

The equity sleeve, which drives majority of fund's risk budget and return potential with the average weight of 50.1% throughout the reporting period, was up +17.0%, lagging the MSCI World benchmark which was up +23.8%, both in euro terms. The first quarter proved challenging for the strategy in the environment supportive of value stocks & cyclical assets. The sleeve, being predominantly quality-growth orientated, in line with its strong ESG credentials, faced a style headwind which led to underperformance compared to the broad market. However, since the second quarter the strategy has recovered some ground on a relative basis, supported by a more favorable style dynamics. Top contributing stocks throughout the reporting period were NVIDIA, ASML Holding and Evoqua Water Technologies, while detractors were Innergex Renewable Energy, Nintendo and IPG Photonics.

The credit sleeve, with the average weight of 28.9% throughout the reporting period, was up +0.5%, ahead of the iBoxx Euro Corporates index which returned +0.2%, both in euro terms on a hedged basis. Overweight to the real estate, telecommunications and consumer services sectors, as well as lower rated BB credit, worked well on a relative basis. Being underweight single A as well as utilities detracted from relative performance. Top contributing issuers were Natwest, Centene and Co-operative Group, while detractors were Elanco Animal Health, European Investment Bank and Experian Finance.

The government bond sleeve, with the average weight of 19.9% throughout the reporting period, outperformed the benchmark sovereign bond index ICE BofA Global Government, returning -1.2% vs -1.7%, both in euro terms on a hedged basis. Most of the positive relative performance was generated in the first quarter, with the structural positioning for steeper curves in US and Europe performing well.

The cash sleeve, with the average weight of 1.2% throughout the reporting period and slightly elevated due to flow commitments, was a drag on performance.

#### AILIS BRANDYWINE GLOBAL OPTIMISER - first NAV April 5, 2021

The portfolio returned a 43 bps (Retail Class) for the partial period (April 6 through August 31).

Positioning and Performance - After the swift move upward in global yields during the first quarter of year, the bond market went through a consolidation phase retracing part of the change in the second quarter. As a result, the portfolio's duration positioning, led by its exposure in corporate credits, was accretive to the portfolio's total return. Investment grade corporate performance has been the top contributor to performance, but high yield credits have been the driver in recent months. The chase for yield continues to motivate investors to move down in credit quality. US corporate high yield bonds continued to serve as a bright spot, producing 0.5% of positive return, outperforming European high yield bonds. The CCC segment of the HY index was the top performer, followed by BB-rated bonds. Global high yield spreads narrowed following widening in July and August 12bps tighter. Our corporate credit portfolio remains allocated to pro-cyclical companies and we are selective in our credits as valuations are not overly compelling. We continue to focus on companies that have pricing power in the current environment, mainly in BB and BBB rated names. We remain heavily allocated to the US, though we hold a few credits in Europe and Asia. These are selective positions rather than a structural exposure, as we believe there is a stronger yield premium to be harvested in the US relative to other regions.

Emerging markets played a mixed bag for the portfolio during the period, as Colombian and Brazilian local debt and hard-dollar corporate bonds provided consistent strong income. The positions were offset by a Mexican sovereign bond purchase that was ill-timed with the Federal Reserve's (Fed) perceived hawkishness in mid-June.

The most significant detractor for the period was the short Treasury exposure used partially to hedge the portfolio's investment-grade bonds' interestrate sensitivity. Lastly, the structured product positions were accretive to the portfolio's positive returns. Delinquencies continue to lower within residential real estate, and strong housing fundamentals remain a positive backdrop for further spread compression. Most recently, we increased the portfolio's overall duration by just under a quarter of a year to roughly 6 years. About 1.6 years of duration in the portfolio is from sovereign bonds, 1 year of which is based in safe-haven duration such as Treasuries and French government bonds.

Outlook - The trajectory of global GDP is expected to converge toward the pre-pandemic potential trend; growth is expected to be stable and long-lasting, inflation transitory, and retreats from policy stimulus are not expected to be turbulent.

This benign outlook is dead center in the distribution of possible macro-outcomes that could result in phase 3, which probably says more about uncertainty than conviction given the distortions. The hot and cold tails on the distribution curve of macro information risk likely are fat and long. If there is any tilt to the bias in the outlook, it is probably that the world runs too hot. A growing number of high-profile investors have been expressing this concern, particularly in the U.S., focusing on perceptions of reckless central banking policy and the unintended consequences of the green/redistributionist agendas spreading across western governments.

Unfortunately, there is no post-pandemic roadmap to follow. However, China is furthest along, so its experience is worth noting. The authorities provided modest stimulus to the economy during the pandemic, choosing to support companies rather than provide income to people. They retreated from stimulus measures as soon as the pandemic was brought under control. In other words, the Chinese economy has been in phase 3 for a while. The household savings rate has not retreated, and economic surprises have been negative. At this juncture, trends in social credit suggest slower growth this year and into 2022. Producer price inflation is soaring because of commodity prices, but consumer price inflation is stable, so far. Bond yields have been drifting lower since November, the Shanghai Composite is up marginally, and the authorities do not want a stronger currency.

Western central bankers are unlikely to turn off the taps prematurely, especially with fiscal policy in retreat. Instead, they are emphasizing the underemployed as well as the new data-dependent frameworks. They want inflation higher than in the past. Supporting this new bias is a mission creep in monetary policy, which links the monetary policy outlook to things like income inequality, diversity and inclusion, and climate change—in other words, fiscal policy. For example, the Bank of Japan is providing direct funding support for climate-friendly corporate spending initiatives.

The pandemic may have super-charged developments affecting the supply side of the economy that were beginning to unfold before the crisis. Productivity usually rebounds during this phase of an economic recovery, but developments in the industrialization of technology suggest the digitization trend will only grow. Digitization of business activities has permitted real GDP to normalize with nine million people still unemployed, which translates to major productivity gains. The macro implications are a long-term boost to potential GDP of unknown magnitude, which implies that aggregate spending will need to keep pace in order to support price inflation.

All these implications suggest that a "hot" macro outcome for phase 3 will require a significant private sector spending agenda, particularly with China coming off the boil and assuming no lingering aftershocks from the pandemic or its variants.

#### MANAGEMENT'S REPORT (CONTINUED)

#### AILIS BLACKROCK ESG BALANCED - first NAV May 7, 2021

Positioning and Performance - Performance since inception was positive. This was driven predominantly by the allocation to Developed Market Equities in the context of a broadly strong period for risk assets.

Both Government Bonds and Non-Government Bonds also contributed positively as yields have, in aggregate, fallen over the period (yields move inversely to price). Their contribution was smaller than that of equities given more modest price action and the relatively lower allocation in the sub-fund.

ESG Thematic Alternatives, Emerging Market Equities and Commodities exposure were all additive to returns but to a lesser degree given their relatively modest allocation sizes within the sub-fund.

In contrast, the sub fund's exposure to Currency detracted modestly, reflective of an underweight exposure to the US Dollar, which appreciated over the timeframe.

Within Equities, returns were generated from a mixture of strategies. The BlackRock ESG Systematic Active Equity, iShares MSCI SRI UCITS ETF and the bespoke US Enterprise Technology equity basket were key drivers of returns. These positive returns were modestly offset by negative performance earlier in the period from the UK Re-Opening Equity Basket, Topix Options and Bounce Back Equity Basket as more cyclical exposures linked to the global economic recovery underperformed.

Within Fixed Income, the BlackRock Global Fixed Income Portfolio was the primary contributor to returns. The iShares USD High Yield Corporate Bond ESG UCITS ETF also contributed positively. In contrast, Government Bond exposure utilized for hedging purposes detracted over the period.

Within ESG Thematic Alternatives, the picture was broadly positive with the SDCL Energy Efficiency Income Trust pic the primary contributor whilst the Aquila Renewable Income Fund has a marginally negative impact on returns.

Market Outlook - The sub-fund reflects a pro risk stance, but the managers continue to explore diversifying sources of alpha and focus on exploiting tactical opportunities.

The primary activity over the period focused on adjusting the construction of the Developed Market Equity exposure. Given the managers' view that we are moving past the peak of fiscal stimulus and growth, the portfolio rotated exposures to quality/defensive stocks at the expense of prior holdings in more cyclical/value stocks.

The sub-fund has a modest duration profile given the managers' expectations for yields to rise from here.

The managers continue to seek opportunities for diversification and resilience from ESG strategies. For example, a new ESG strategy was added over the period in the form of the bespoke Biodiversity and Natural Capital equity basket which seeks to allocate to companies whose revenues are linked to the preservation of land, forest and sea diversity.

### NOTES TO THE FINANCIAL STATEMENTS AT AUGUST 31, 2021

#### 1. GENERAL INFORMATION

AILIS (the "Fund") was established on June 21, 2017, in the Grand Duchy of Luxembourg under Luxembourg Law in the form of a SICAV (Société d'Investissement à Capital Variable). The Fund is governed by Part I of the Luxembourg Law of December 17, 2010 relating to undertakings for collective investment (the "Law").

As of August 31, 2021, the number of active sub-funds in the Fund (the "sub-fund(s)") is eighteen, each one having a specific investment policy.

During the Financial year 2020 – 21, the following sub-funds have been launched:

- AILIS JPM STEP-IN ALLOCATION (First NAV 03/11/2020)
- AILIS SCHRODER GLOBAL THEMATIC (First NAV 20/10/2020)
- AILIS JANUS HENDERSON GLOBAL ACTIVE OPPORTUNITIES (First NAV 22/12/2020)
- AILIS BRANDYWINE GLOBAL IM BOND OPTIMISER (First NAV 06/04/2021)
- AILIS BLACKROCK BALANCED ESG (First NAV 10/05/2021)

Further to redemptions requests received for the five Sub-funds AILIS RISK PREMIA CARRY, AILIS RISK PREMIA MOMENTUM, AILIS RISK PREMIA VALUE, AILIS RISK PREMIA QUALITY and AILIS RISK PREMIA EQUITY all the shares of the Sub-funds have been fully redeemed with NAV calculated on April 1, 2021 and referring to March 31, 2021.

With effective date as of April 1, 2021 depositary bank and fund administration, including central administration, paying agent, and registrar and transfer agent services (the "Fund Services") have been taken over by STATE STREET BANK INTERNATIONAL GmbH, Luxembourg Branch. Therefore, all rights and liabilities arising from the previous agreements with FIDEURAM BANK (LUXEMBOURG) S.A. ("FBL") in relation to the Fund Services have been transferred to STATE STREET BANK INTERNATIONAL GmbH, Luxembourg Branch, the Luxembourg branch of State Street Bank International GmbH being a credit institution incorporated and existing under the laws of Germany (Gesellschaft mit beschränkter Haftung), having its registered office at 49, Avenue J.F. Kennedy, L-1855 Luxembourg, Grand Duchy of Luxembourg and registered with the Luxembourg trade and companies register under RCS number B148186.

FIDEURAM BANK (LUXEMBOURG S.A.) continue to provide domiciliation services to the Company, whose registered address will remain at 9-11, Rue Goethe, L-1637 Luxembourg.

#### Covid-19 Outbreak

From the very beginning of the dramatic health and social emergency, all relevant parties involved in the Fund have been fully committed to tackling the situation effectively, whilst ensuring the continuity of its processes and services; indeed they have put in place robust business continuity programs to manage the situation in the safest and most effective way. As a result, the impacts of this situation in the different Fund activities, whether direct or indirect, have been very limited. Despite this challenging context, the objective is to safeguard the Fund's ability to continue as a going concern, so that it can satisfy investors' expectations. The severe phase of the outbreak has been followed by a progressive but constant containment of the virus, accompanied by a gradual recovery in economic and social activities. The economic and market implications of the outbreak are closely monitored to protect investors from unexpected losses and to give a true and fair value of the financial position at each valuation point. There are no specific accounting implications for this situation to be reported.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared using accounting principles generally accepted for such investment funds in Luxembourg, which include the following significant accounting policies:

#### a) Foreign currency conversion

Assets and liabilities denominated in currencies other than EUR are converted at the closing spot rate of the Net Asset Value date. Foreign currency trades are converted at the closing spot rate of the transaction date and then revaluated daily at the closing spot rate of the NAV date. Income and expenses expressed in currencies other than the accounting currency of the sub-fund are converted into the latter at the closing spot rate of the transaction date. Realized and unrealized foreign currency gains or losses are included in the result of operations of the Financial year.

#### b) Valuation of investments

Listed securities as well as securities traded on other organized markets are valued at the latest available market prices as of the Net Asset Value date. Other securities are valued at their estimated market prices according to the Pricing Policy established by the Board of Directors of the Fund.

Units/shares of Undertakings for Collective Investment, either listed or not, are valued on the basis of their last available Net Asset Value.

### c) Income recognition

Interest income is recorded on an accrual basis and dividend income is recorded on a dividend ex-date basis, net of withholding tax if any.

### d) Carrying value of securities

The carrying value of securities is determined on a weighted average cost basis. It includes purchase price, brokers' fees and taxes.

#### e) Transaction costs

Transaction costs are included in the caption "Transaction costs" of the Statement of Operations and Changes in Net Assets, which is available free of charge upon request at the registered office of the Fund.

### NOTES TO THE FINANCIAL STATEMENTS AT AUGUST 31, 2021 (CONTINUED)

#### f) Allocation of expenses

All the expenses directly and exclusively attributable to a certain sub-fund are borne by that sub-fund. If it cannot be established that the expenses are directly and exclusively attributable to a certain sub-fund, they will be borne proportionally by each sub-fund.

### g) Set-up costs

The expenses originated during the establishment of the Fund are amortized over a 5 years' period.

Where further sub-funds are created, these sub-funds bear their own set-up costs. The set-up costs for new sub-funds created may, at the discretion of the Board of Directors of the Fund, be amortized on a straight-line basis over 5 years from the date on which the sub-funds started activity. The Board of Directors of the Fund may, in its absolute discretion, shorten the period over which such costs are amortized.

### h) Forward foreign exchange contracts

Forward foreign exchange contracts are valued at the market forward rates for the remaining period from valuation date to maturity date.

### i) Future contracts

Initial margins, consisting of cash that is segregated upon entering into future contracts, are recorded in the caption "Initial margin on future contracts" in the Statement of Net Assets. The daily gain or loss on open future contracts is calculated as the difference between the market prices as of the Net Asset Value date and the prices of the previous Net Asset Value date.

Daily gains and losses on future contracts are directly recorded in the caption "Net realized gains/(losses) on future contracts" of the Statement of Operations and Changes in Net Assets (which is available free of charge upon request at the registered office of the Fund) and are credited/debited in the cash accounts.

During the period ended August 31, 2021, the company in charge for the clearing on futures contracts was BNP Securities Services.

#### j) Swap contracts

Credit Default Swaps and Interest Rate Swaps shall be valued respectively at fair value on the basis of the last known closing quotation of the underlying asset or valued using a discounted cash-flow computation. The unrealized gain or loss on Swaps is disclosed in the Financial Statements.

### k) Option contracts

Óptions listed as well as options traded on other organized markets, are valued at the latest available market prices as of the Net Asset Value date.

Not listed options are valued at their estimated market prices as determined according to the Pricing Policy established by the Board of Directors of the Management Company, which include various best practice Option valuation models according to the nature of the Option.

### I) Combined Statements

The Fund's Combined Statements of Net Assets is the sum of the Statements of each sub-fund as at August 31, 2021. There are no Cross sub-funds' investments (i.e. where one sub-fund has invested in another sub-fund of the Fund) as at August 31, 2021.

### m) Use of Total Return Swaps

Total Return Swaps ("TRS") is defined as a derivative contract in which one counterparty transfers the total economic performance of a portfolio or basket of assets to another counterparty. For any Sub-fund involved, the details of relevant Underlying Portfolios are available on request to sharetholders at Fund's and Management Company's registered offices. Total Return Swaps contains, if any, the dividends, accrued interests, financing costs and accrued commissions linked to the above-mentioned swaps.

### NOTES TO THE FINANCIAL STATEMENTS AT AUGUST 31, 2021 (CONTINUED)

### n) To be Announced Contracts

To-Be-Announced contracts ("TBA") are forward agreements on Mortgage-backed securities ("MBS") baskets included in the "Investments in marketable securities" caption in the Statement of Net Assets. The term TBA is derived from the fact that the actual MBS that shall be delivered to fulfil a TBA trade is not designated at the time the trade is made. The securities shall "be announced" 48 hours prior to the settlement date. TBA trade settlements are often scheduled significantly into the future, but valuation and accounting methodologies applied are not different from transferable securities ones.

### 3. DERIVATIVES

Each sub-fund may enter into derivatives contracts such as: forward foreign exchange, future, swap and option.

#### 10. TAXES

According to Luxembourg law, the Fund is not subject to any income tax, but is liable to a subscription tax ("Taxe d'Abonnement") at an annual rate of 0.05% of its Total Net Assets, payable quarterly and assessed on the last day of each quarter.

With regard to Class shares or sub-funds offered exclusively to Institutional Investors, the subscription tax rate is reduced to 0.01% per year.

Value of assets represented by units/shares in other Luxembourgish undertakings for collective investment ("UCI") is exempted from the Taxe d'Abonnement provided that such units/shares have already been subject to the tax.

# 11. MANAGEMENT COMPANY, INVESTMENT MANAGERS, DEPOSITARY BANK, ADMINISTRATIVE AGENT AND TRANSFER AGENT

#### **Management Company**

The Fund is managed by Fideuram Asset Management (Ireland) dac (the "Management Company"), an Irish company, fully owned by Fideuram – Intesa Sanpaolo Private Banking S.p.A. The Management Company is registered with the Irish Register of Companies under number 349135.

#### Management Fees

The Fund pays to Fideuram Asset Management (Ireland) dac a management fee that ranges from 0.30% to 1.70% per year of each sub-fund's monthly average net assets, payable at each month end.

#### Performance Fees

The Investment Manager and/or the Management Company may earn a performance fee.

No performance fees have been charged during the Financial year. As at August 31, 2021, no sub-fund is subject to performance fees.

### **Investment Managers**

The Management Company has designated the following companies as Investment Manager (hereafter the "Investment Managers"):

The Management Company acts as Investment Manager for all the other sub-funds and keeps the control and responsibility on all sub-funds.

### Arrangements

The Investment Managers have entered into soft commissions arrangements with brokers under which certain goods and services related to their professional activities, such as economic research, financial analyses, statistics, as well as computer services used to support investment decision making, are received by the Investment Managers. Such arrangements are only agreed with such legal entities for the interest of the Fund. It should be noted that soft commissions earned by some sub-funds managed by an Investment Manager may be used to purchase services that also benefit other non-participating sub-funds managed by the same Investment Manager.

#### Central Administration

The central administration fee is equal to 0.135% per year calculated on the basis of the end of month Net Asset Value of each sub-fund and payable to the Management Company at the beginning of the following month.

### Administrative Agent

The Management Company has appointed as Administrative Agent, in charge of the daily calculation of sub-fund's Net Asset Value:

The custodian fees are equal to 0.045% (excluding VAT) per year calculated on the basis of the end of month Net Asset Value of each sub-fund and payable at the beginning of the following month.

### **Domiciliary Agent**

The fund has appointed Fideuram Bank (Luxembourg) S.A. as Domiciliary Agent. The Domiciliary Agent is entitled to receive fees out of the assets of the Fund for an amount of EUR 6,000 per month.

#### 12. SECURITIES LENDING

Fund's portfolio securities may be lent to credit institutions and other financial institutions of high standing. The Fund has the right to request, at any moment, the termination of the contract and the return of securities.

Securities lending is guaranteed by government securities and other bonds with a minimum rating of upper medium grade. Any transaction expenses in connection with such loans are charged to the borrowers.

The Management Company has designated Fideuram Bank (Luxembourg) S.A. as Agent under a securities lending authorization agreement.

Fideuram Bank (Luxembourg) S.A. is a related party to the management company being fully owned by ISP group.

For the Financial year ended August 31, 2021, Fideuram Bank (Luxembourg) S.A. acting as Agent had a Securities Lending Agency Agreement in place with Goldman Sachs International Bank for equity portfolio the latter lending securities to approved borrowers. With regard to bonds portfolio, security lending transactions were mainly conducted under a Principal Lending Programme with Clearstream Banking S.A. coupled with an automated Agency Lending Programme.

#### 13. NET ASSET VALUE PER SHARE

For each sub-fund the Net Asset Value per share is computed daily by dividing the Net Assets by the number of shares outstanding.

### 14. DISTRIBUTION OF PROFITS

In accordance with the Fund's prospectus, sub-funds' profits are not distributed but reinvested, except for the share class S, characterized by the distribution of dividends.

### 15. PLACEMENT FEE

For certain sub-funds the Management Company was entitled to receive a placement fee, the existence and amount of which was defined according to the following conditions:

For the sub-funds Ailis M&G Collection, Ailis Invesco Income, Ailis Man Multi-Asset, Ailis BlackRock Multi-Asset Income, Ailis PIMCO Target 2024 (classes R, S), Ailis Pictet Balanced Multitrend, Ailis Muzinich Target 2025 (classes R, S), Ailis Fidelity Flexible Low Volatility and Ailis Franklin Templeton Emerging Balanced, a Placement Fee, equals to 2.00% of the initial Net Asset Value per share multiplied by the number of resulting shares being issued, was applied at the end of the initial subscription period; it was levied on the sub-fund's assets collected as formation expenses and was amortized within the next 5 years.

For the sub-funds Ailis Vontobel Global Allocation, Ailis Jpm Step-in Allocation, Ailis Schroder Global Thematic, Ailis Janus Henderson Global Active Opportunities, Ailis Brandywine Global IM Bond Optimiser (classes R, S) and Ailis Blackrock Balanced ESG, a Placement Fee, equals to 1,80% of the initial Net Asset Value per share multiplied by the number of resulting shares being issued, was applied at the end of the initial subscription period; it was levied on the sub-fund's assets collected as formation expenses and was amortized within the next 3 years.

#### **16. REDEMPTIONS OF SHARES**

The Fund's shares are redeemable daily at the current Net Asset Value per share. According to the Fund's prospectus, the redemption of shares can be temporarily suspended.

During the period ended August 31, 2021, no suspension was recorded.

Some sub-funds are entitled to receive a redemption commission applied on the counter value of the number of Shares redeemed based on the initial Net Asset Value per Share. The redemption commission is recognized as a revenue for each sub-fund over the same period and corresponds to the amounts to be amortised of the placement fee levied on sub-funds launch. ### Independent auditor's report

To the Shareholders of All IS

#### Opinion

We have audited the financial statements of AILIS (the "Fund") and of each of its sub-funds which comprise the statements of net assets, the statements of investment portfolio and other net assets, forward foreign exchange contracts, commitments on future contracts, commitments on swap contracts and commitments on option contracts as at August 31, 2021, the statements of operations and changes in net assets for the year then ended, and the notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Fund and of each of its sub-funds as at August 31, 2021, and of the results of their operations and changes in their net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements.

The Management Company applies a remuneration policy and practices that are consistent with, and promote, sound and effective risk management and that neither encourage risk taking which is inconsistent with the risk profiles, applicable rules, the Prospectus or the Management Regulations nor impair compliance with the Management Company's obligation to act in the best interest of the Fund.

#### Principles:

The Management Company adopted remuneration policies and practices that:

- (i) are consistent with and promote sound and effective risk management;
- (ii) do not encourage risk-taking which is inconsistent with the risk profiles, rules or instruments of incorporation of the UCITS funds it manages (hereinafter "the Managed Funds"); and
- (iii) are consistent with the business strategies, objectives, values and interests of the Company, the Managed Funds and the investors in those Managed Funds and include measures to avoid conflicts of interest.

The Management Company's remuneration and incentives policies are founded on the following principles:

- alignment of the conduct of management and employees with the interests of shareholders, clients and the related managed assets;
- merit, with a view to ensuring a clear correlation with the performance and managerial qualities shown;
- fairness, with a view to fostering honest conduct and standardising remuneration packages;
- sustainability, in order to contain the costs arising from the application of the remuneration and incentives policies within a range of values that is compatible with medium and long-term strategies and annual objectives;
- proportionality based on the role held by staff members;
- compliance with the regulations in force.

The Management Company decided to entrust its Audit and Remuneration Committee with the advisory and consulting functions aimed to support the Board of Directors in all activities relating to remuneration, defined in accordance with the principles set out in the ESMA Guidelines on sound remuneration policies (ESMA 232/2013 and 411/2016). The Audit and Remuneration Committee has an advisory and consulting role aimed to support the Board of Directors in all the activities relating to remuneration.

The Remuneration Policy includes fixed and variable components of salaries and applies to all categories of staff, including senior management, risk takers, control functions and any employee whose professional activities have a material impact on the risk profiles of the Management Company and the Managed Funds.

The fixed component is defined based on contractual conditions, the position held, responsibilities assigned, and the specific experience and competencies gained by the employee.

The variable component is linked to personnel performance and proportional to the results achieved, keeping a prudential approach to risk, and is formed by:

- variable component, paid through the incentive and bonus systems
- any stability agreements, non-compete agreements, retention allowance and similar.

The remuneration policy is subject to an annual central and independent internal review, to ensure that:

- the overall remuneration system operates as intended;
- the remuneration pay-outs are appropriate;
- the risk profile, long term objectives and goals of the Managed Funds are adequately reflected; and
- the policy reflects best practice guidelines and regulatory requirements.

The Group internal audit function conducts yearly missions on the rewarding and incentive system at the Management Company level. The audit conducted during the Financial year 2019 revealed a positive picture, characterised by an appropriate implementation of the organisational model. Lastly, no irregularities have been detected in terms of individual compliance breaches among employees.

SFTR covers a variety of transactions such as securities lending, repurchase (Repo) or reverse repurchase transactions, buy-sell back or sell-buy back transactions but also Total Return Swaps ("TRS") defined as a derivative contract in which one counterparty transfers the total economic performance, including income from interest and fees, gains and losses from price movements, and credit losses, of a reference obligation to another counterparty.

For the Financial year ended August 31, 2021 the partners for the lending activity (principals or sub-agents) chosen by the Agent were Goldman Sachs International Bank and Clearstream Banking S.A. Both agreements in place with the partners provide an indemnification clause covering lending Agent activities in case of default of the borrowers.

Securities lending is primarily driven by market demand for specific securities and is used, for instance, to cover short selling or settlement failures. In this type of transaction, the lending counterparty lends securities for a fee against a guarantee in the form of financial instruments or cash given by its clients or counterparties.

Repos/reverse repos are generally motivated by the need to borrow or lend cash in a secure way. This practice consists of selling/buying financial instruments against cash, while agreeing in advance to buy/sell back the financial instruments at a predetermined price on a specific future date.

This disclosure aims to improve the transparency of securities financing transactions (SFTs) and TRS.

#### Please note that:

- as of August 31, 2021, no repurchase or reverse repurchase agreement transactions nor buy-sell back or sell-buy back transactions were in place;
- all OTC derivative transactions entered under an ISDA Master agreement are netted together for collateral purposes; therefore, any collateral disclosures provided hereinafter are in respect of all OTC derivative transactions entered into by the Sub-funds under an ISDA Master agreement, including Total Return Swaps.

As regards the quality of Collateral, the Fund only accepts very high-quality collateral. For more information about acceptable collateral please refer to specific sections of the prospectus including but not limited to the information on liquidity, issuer credit quality, maturity and haircuts.

Collateral must at all times meet with the following criteria:

- a) Liquidity: Collateral must be sufficiently liquid in order that it can be sold quickly at a robust price that is close to its pre-sale
- b) Valuation: Collateral must be capable of being valued on at least a daily basis and must be marked to market daily.
- c) Issuer credit quality: The Fund will ordinarily only accept very high-quality collateral.

# OTHER INFORMATION TO SHAREHOLDERS (UNAUDITED) (CONTINUED)

- d) Correlation the collateral will be issued by an entity that is independent from the counterparty and is expected not to display a high correlation with the performance of the counterparty.
- e) Collateral diversification (asset concentration) collateral should be sufficiently diversified in terms of country, markets and issuers. The criterion of sufficient diversification with respect to issuer concentration is considered to be respected if the Sub-fund receives from a counterparty of efficient portfolio management and over-the-counter financial derivative transactions a basket of collateral with a maximum exposure to a given issuer of 20% of NAV of the Sub-fund's Net Asset Value. When a Sub-fund is exposed to different counterparties, the different baskets of collateral should be aggregated to calculate the 20% of NAV limit of exposure to a single issuer. By way of derogation from this sub-paragraph, a Sub-fund may be fully collateralized in different transferable securities and money market instruments issued or guaranteed by an UE Member State, one or more of its local authorities, a third country or a public international body to which one or more UE Member States belong. Such a Sub-fund should receive securities from at least six different issues, but securities from any single issue should not account for more than 30% of the Sub-fund's Net Asset Value.
- f) Safe keeping: Collateral must be transferred to the Custodian or its agents.
- g) Enforceable: Collateral must be immediately available to the Fund without recourse to the counterparty, in the event of a default of the latter.
- h) Non-Cash collateral:
  - cannot be sold, pledged or re-invested;
  - must be issued by an entity independent of the counterparty; and
  - must be diversified to avoid concentration risk in one issue, sector or country.

Starting from the last renewal of the mandates, occurred on February 1st, 2019, the lending Agent is only entitled to the reimbursement of direct and indirect costs borne by itself in the execution of its activity, plus an additional remuneration margin.
